NEW BUSINESS:

-Parents voiced complaints that STM is trying to run a select style system for our basketball program.

- Ryan Ousey put a motion on the floor that Sports Monthly Meetings are to have a specific date and time for all monthly meetings. They are to be held on the 2nd Tuesday of every month, at 5:30 P.M. 2nd vote to Maureen Roberts, 3rd vote to Nick Pitsch. (Added after meeting: This is in our bylaws and will need to be done in accordance with the Bylaws. Mr. Ousey was made aware)
- Parents and Coordinators voiced issues with all Officers are not attending the monthly sports meetings.
- There was a miscommunication about the ordering of trash cans for the fields. They will be ordered.
- Chad and Jeff came to talk about the \$20 sports registration incentive. They voiced their concerns and David emailed them his plan on how to accomplish this. They will follow up with David in the coming weeks.
